General Directions to Skinners Falls (41.670, -75.057):

From Pennsylvania and New York via Route 97 traveling north:

- North on New York Route 97, approximately 5.4 miles beyond Fort Delaware museum in Narrowsburg, NY
- o Turn left onto Skinners Falls Road/Rt 44 (follow signs for Lander's Campground at Skinners Falls)
- o Turn left onto Skinners Falls W Rd
- o Parking lot is on the left

From Northern New Jersey or New York via New York Route 17:

- Take NY-17 West to exit 104 towards Monticello/Raceway to NY-17B West
- o Drive approximately 15 miles, NY-17B becomes County Route 114
- o Drive approximately 4.7 miles. At stop sign, turn left onto NY State Route 97 South
- o Drive approximately 2.7 miles, turn right onto Skinners Falls W Rd (follow sign for Skinners Falls)
- Drive approximately 0.7 miles, parking lot is on the left

Directions from Skinners Falls to NEWE Campground, Equinunk, PA:

- Turn right at entrance of the Skinners Falls Access parking lot.
- o At Y in the road take the left-hand fork towards Route 97 north.
- o At the stop sign turn left onto Route 97 north and travel 12.9 miles.
- Turn left onto Mills Bridge Road. Directional signs on Route 97 will indicate that the Kellams Fishing Access is down this road.
- Cross over the Stalker-Kellams Bridge
- o There is an 8-foot height limitation on the Stalker-Kellams Bridge, and it is a one lane bridge.
- Turn right onto River Road. Entrance to NEWE will be on your right.
- The NEWE Campground is located at 4146 River Road, Equinunk, Pennsylvania 18417

General Directions to NEWE Campground, Equinunk, PA:

NOTE: Kellams Bridge has an 8-foot height restriction. If this is a problem, participants should reach the campsite from Pennsylvania or cross the Delaware River at Callicoon, NY and continue on Callicoon Road approx. 6-miles to PA Route 191 and follow the directions from Pennsylvania.



Driving Directions to Bushkill Access / Boat Launch

Bushkill Boat Launch / Access is on US 209 in PA about 1.5 miles north of Bushkill Falls Road. Parking is to the right as you pull into entrance at the far end of the parking lot (Area A on map below). Bushkill Boat Launch (name used by Google maps), also known as Bushkill Access, which is what will be on the Park Service signs on US 209. Registration will be at the far end of the parking area. Overflow parking is available in Area C on the map below, but DO NOT park in Area B. If Area C fills, you will be directed to another lot further south on US 209 after registering and picked up from there.

Note that day trippers will need to provide their own breakfast before arriving at Bushkill Access. The closest option for breakfast is Marluca's Deli on US 209 just south of Bushkill Falls Rd – about 1.5 miles from Bushkill Access.
